Committee Goals for 2020-2021:

- Draft a resolution to ask campus governance bodies and administrations to a) recognize the frequently excessive workload of and demands on BIPOC faculty, and b) recognize EID work in tenure and promotion policies (Winter).
- In collaboration with Student Life Committee, draft a resolution on chosen name and pronoun in faculty-facing databases (Winter)
- A sub-committee will explore the possibility of hosting a web page on Inclusive Pedagogy, with links and multimedia resources, on the SUNY ODEI website.

- A sub-committee will explore how to enable more students from traditionally underrepresented groups to take advantage of high impact learning practices, such as Study Abroad. We will engage SUNY ODEI and EOP programs in this conversation.
- The committee identified sections in the SUNY Diversity Action Plan (DAP) on which we would like to get more feedback from campuses. Sectors will discuss these sections at the Fall Plenary and a session later during the Plenary is devoted to a Q & A on the topic with two members of the SUNY Diversity Committee. The committee will use the information gathered from the sector meetings and the Q & A to determine possible further action based on the SUNY DAP.
- The committee will examine issues surrounding implementation of the required Diversity category in the new SUNY General Education Framework, especially concerning subject matter expertise of the faculty teaching these courses.
- The committee will explore the intersections of SUNY DAP, the General Education
 Diversity requirement, the Racial Equity and Social Justice Curriculum resolution, and the
 BLM resolution to identify issues that the committee may need to address.
