# SUNY DLE User Feedback

## Faculty/Student Surveys Fall 2022 – Preliminary Results

### 417 C1 and C2 Faculty

- Faculty tended to be able to complete the specified task/action
- Faculty **satisfaction** with their ability to complete the task was **mixed**
- 100 have volunteered to participate in focus groups
- 128 have volunteered to participate in more in-depth surveys

### 1684 C1 and C2 Students

- Students are overwhelmingly using computers to access Brightspace
- Skewed left (satisfied) distribution for Brightspace navigation
- Appear to have slightly more respondents (by %) who were able to complete the target tasks, as compared to faculty
- Student satisfaction with ability to complete the task was slightly more positive than faculty
- 139 students volunteered to participate in focus groups

## Campus, Faculty & Student Feedback on DLE Templates

The 2nd round of feedback has been collected from Cohort 1 & 2 Fall 2022 campuses, faculty, and students. Analysis has been completed.

- Compressed timeframe impacted campus ability to implement templates.
- Consistency & navigation issues were key results, indicating challenges w/Instructor training, BS communications & the gradebook.

A non-credit template is being discussed.



## Additional Feedback

We have concluded our engagement with the D2L Design Team to provide feedback on the DLE Course Templates, and planning changes based on their feedback.

Provided a 1st round of formal observations/ recommendations to the DLE Campus Implementation Team per our charge, based on all feedback received to date.



## Focus Group Input

Campus, faculty, & student focus groups w/ volunteers from Niagara, Adirondack, FLCC, MCC, Columbia Greene & Farmingdale have taken place..

- The team met with Niagara, FMCC, FLCC and ADK for an overview of their experiences implementing the templates.
- Student focus groups are in progress/taking place.



## Additional Resources

A *FAQs about the Templates* has been developed and published on the DLE website in response to feedback and questions about the DLE Templates.

A *Templates Design Rationale* document is being developed based on feedback as additional resource for campuses, IDs, and faculty using the SUNY DLE Templates.

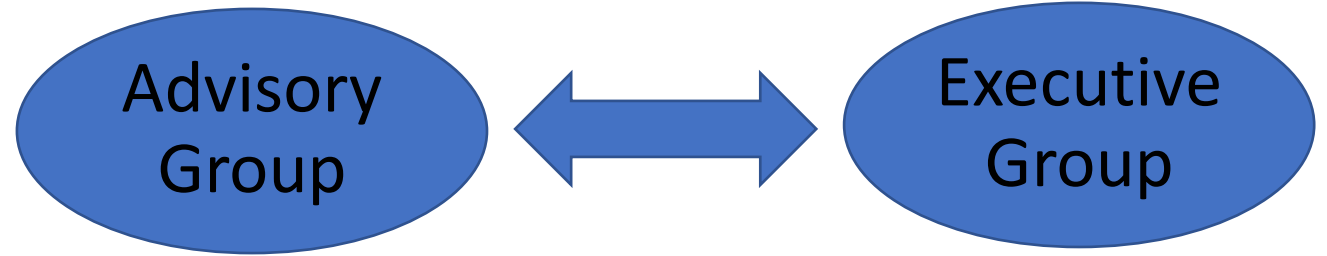
- What structure do we need to have in place to enable the right campus representation whereby:

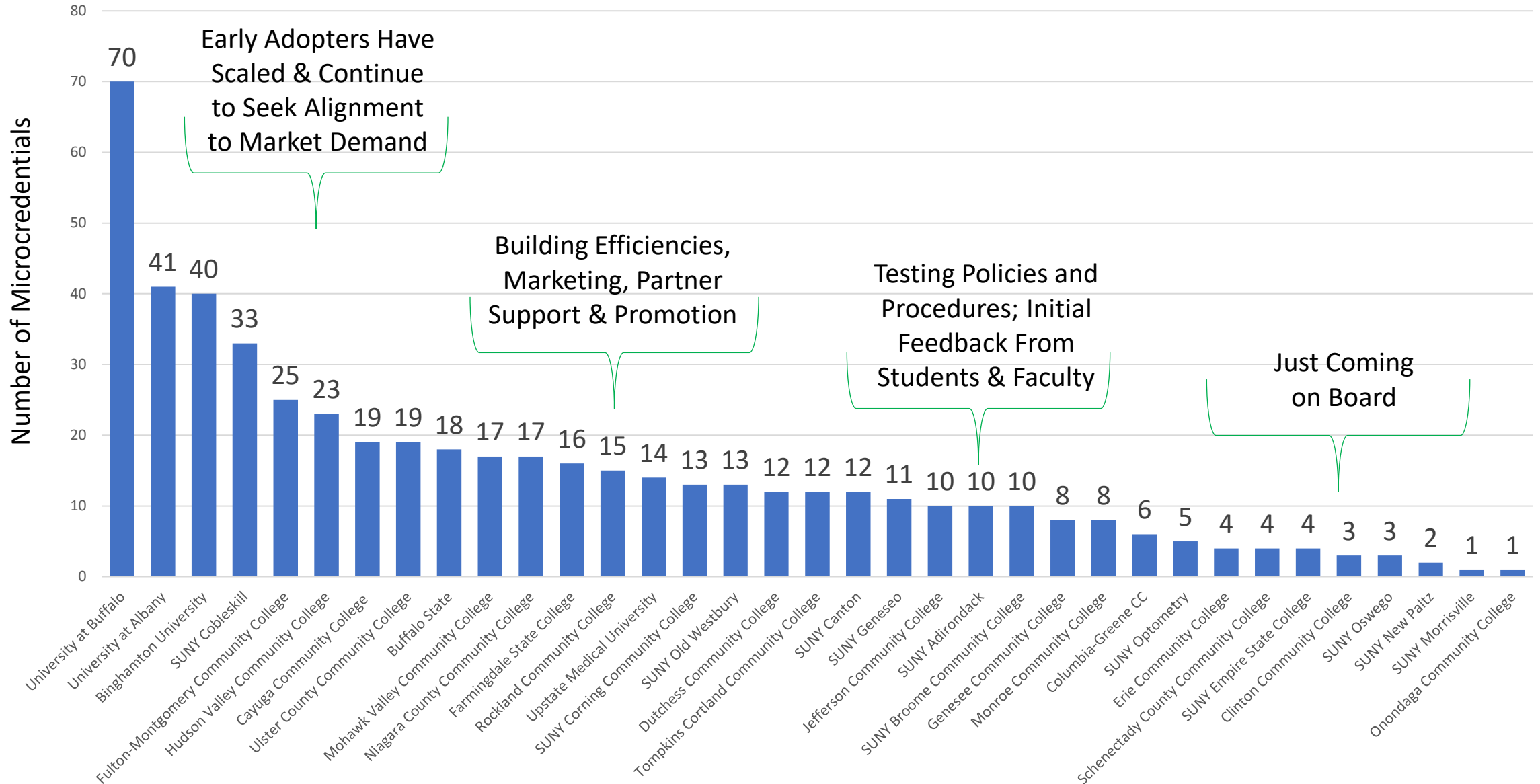

# Stats by Sector

## Community Colleges (10 of 30):

- 98% open to the public
- 94% stackable
- 92% credit bearing
- 35% fully online

## Comprehensive Colleges (6 of 13):

- 49% open to the public
- 34% open w/ permission of Chair
- 98% stackable
- 100% credit bearing
- 36% fully online

## Technology Colleges (4 of 7):

- 89% open to the public
- 69% stackable
- 64% credit bearing
- 49% fully online

## Doctoral Granting (5 of 10):

- 62% open to the public
- 3% open w/ permission of Chair
- 27% stackable
- 25% credit bearing
- 49% fully online

# Priority Goals

- **Data, Data, Data**
- **Microcredential Advisory Group**
  - Co-Chairs suggest broad group like DLE Advisory Group that serves as vehicle for communication and then a handful of smaller working groups
  - Key areas of focus:
    - Data analysis/research to identify disciplinary “gaps” in current catalogue as compared to local, regional, and state needs and recommend a process for meeting identified gaps
    - Establish a process for responding to requests for state-wide or system-wide partnership opportunities
    - Consider and provide guidance on commonly asked questions not addressed in existing policy/practice documents, ex. when/how to sunset a microcredential
    - Consider needed policy updates and/or creation of a Memorandum to Presidents and make recommendations to Provost-in-Charge

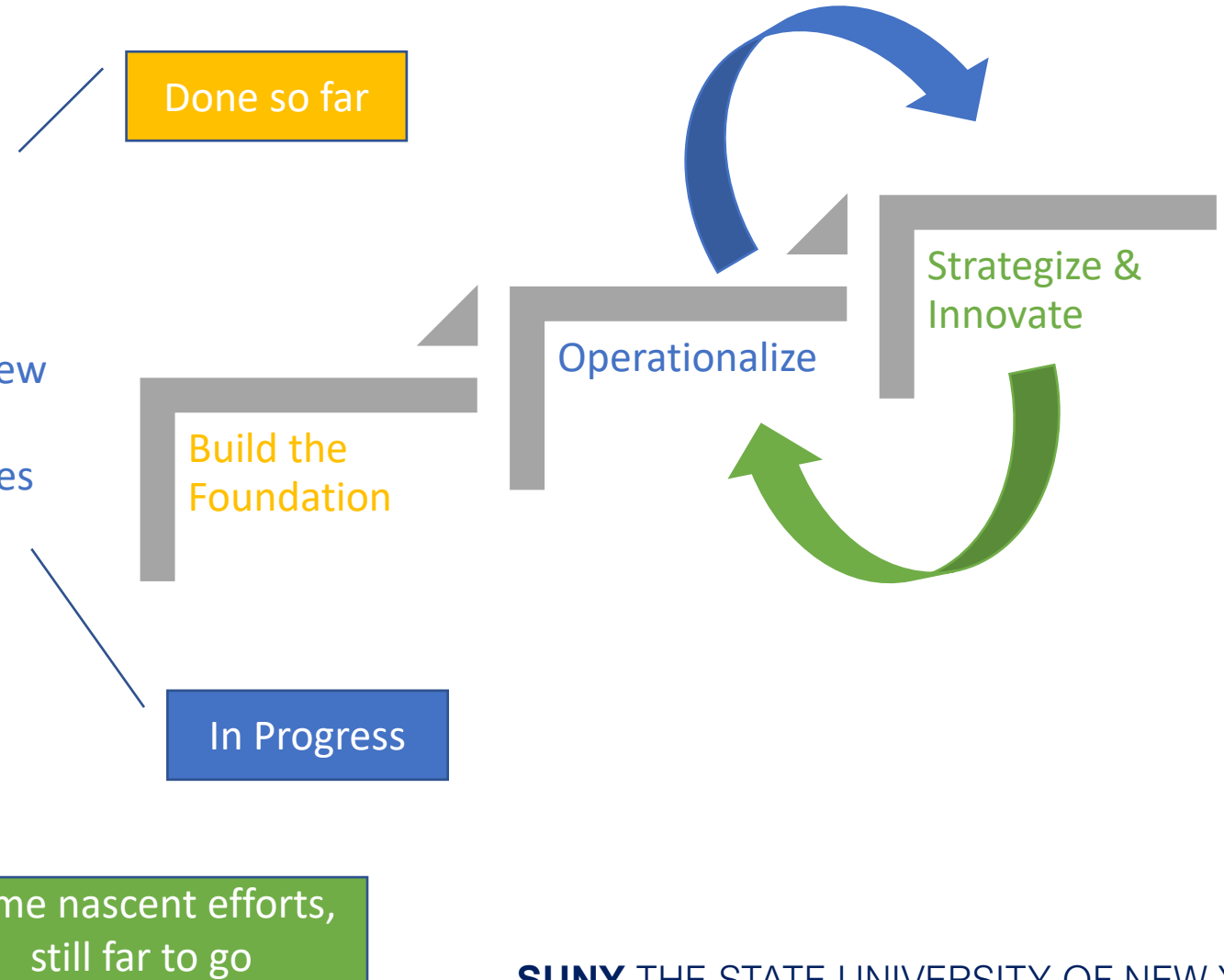

- So that we can use data to drive strategic programs and innovate





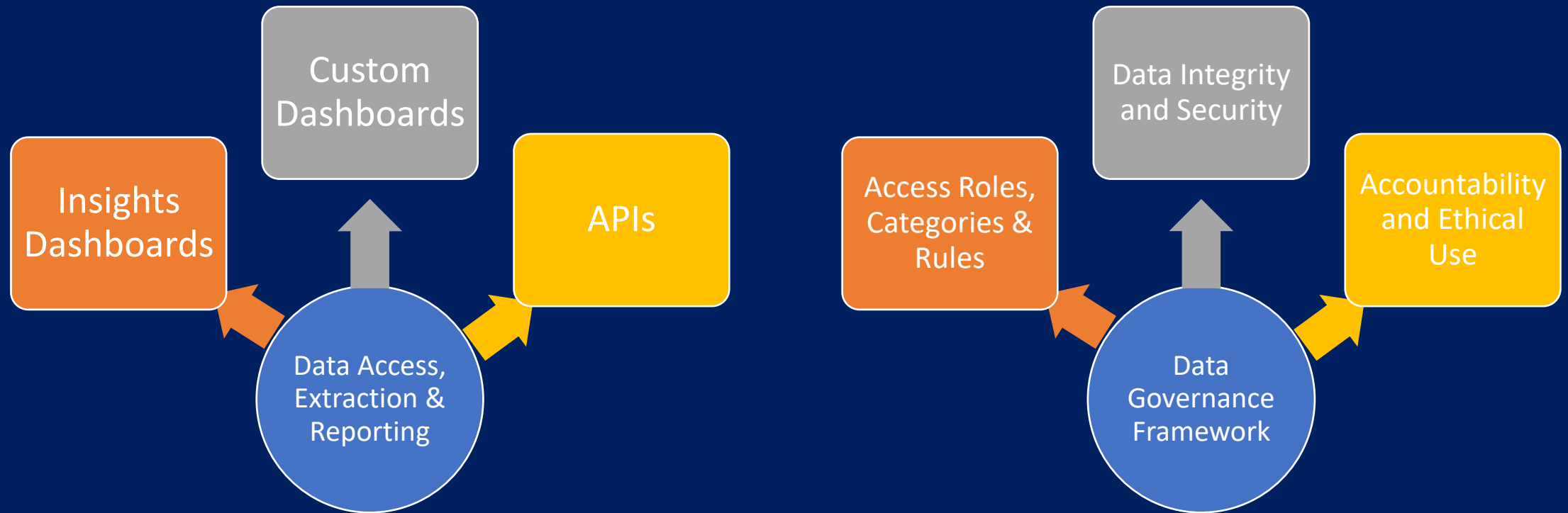

# Research Seed Grant Program: NIH and NSF Resubmissions

- Four rounds in this cycle
  - Round 1 awards made in December 2022
  - Round 2 under review now
  - Round 3 due March 31, 2023
  - Round 4 due June 30, 2023
- Round 1: 49 proposals received; 11 awards made (~\$435K)
- Round 2: 27 proposals received



# Empire Innovation Program

- Proposals due from campuses January 27, 2022
- ORIED will be contacting faculty to serve as subject matter experts
- Topics
  - Cancer: Vaccines, Early Detection, Precision Medicine
  - Climate Science
  - Clean Energy
  - Cybersecurity, Computer Vision and Trustworthy AI
  - Microelectronics
  - Pandemics: Prevention, Detection and Treatment
  - Public and Community Health (including Mental Health)
